REPORT OF SCRUTINIZER **[E-VOTING]**

[Pursuant to section 110 of the Companies Act, 2013 and rule 20 & 22 of the Companies (Management and Administration) Rules, 20141

I, B. Krishnamoorthi, BSc, FCA Practicing Chartered Accountant, was appointed as Scrutinizer for Postal Ballot and to ascertain the requisite majority in a fair and transparent manner on the votes cast through Ballot forms received through post and E-Voting in respect of Postal Ballot carried out as per section 110 of the Companies Act, 2013 and rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 on the resolution referred to in this report.

I submit my report as under:

- The E-Voting period remained open from 09.00 AM on Sunday 27th March, 2016 up to 05.00 PM on Monday 25th April 2016.
- The Notice was sent to all the Members, whose names appeared in the Register of Members as on 18th March, 2016 (cut-off date), who were entitled to vote on the proposed 2 (Two) Resolution as mentioned in the Notice of the Postal Ballot dated 18th March 2016 of "Raishree Sugars & Chemicals Limited" by email to those shareholders who had registered their email id's and by registered post to other shareholders to their registered address.
- The Votes cast through E-Voting were unblocked on 25th April, 2016 around 05.45 pm in the presence of two witnesses, namely Mr.K.Marimuthu and Mr.R.Sasidharan, who are not in employment of the Company.
- In terms of the mandatory provisions of Regulation 44 of SEBI (LODR) Regulations 2015, read with Rule 22 of the Companies (Management and Administration) Rules, 2014, the Company had provided to the shareholders, an option to send their assent or dissent in writing on a postal ballot or through electronic means. The postal ballot forms were dispatched to the shareholders along with the Notice of Postal Ballot and a self addressed Business Reply Envelope. Voting rights reckoned on the shareholding as on the above mentioned cut-off date i.e. 18th March, 2016. The last date for receipt of the physical ballot forms was on 25th April, 2016. The physical ballot forms received up to the last date stated above, were diligently scrutinized and reconciled with the records maintained by the Registrars and Share Transfer Agents of the Company viz.
